

Sarah Furnace Cave Is the Longest Surveyed Cave in the Northeastern US

A group of surveyors from the Mid-Atlantic Karst Conservancy called "Team Sarah" has announced that Sarah Furnace Cave is now the longest surveyed cave in the northeastern US. McFails Cave long sat atop that list, but McFails is now number two.

In June 2022, the survey of Sarah Furnace Cave reached 7.26 miles, surpassing the 7.19 miles attributed to McFails cave by Bob Gulden's website, caverbob.com. Although both caves may in fact be longer, Team Sarah has been actively working on surveying the Pennsylvania cave since May 2019 and has over 100 virgin leads. Indeed, there is so much cave left to survey that Team Sarah schedules 2 or 3 survey trips every month, for a year in advance.

Sarah Furnace Cave may also be the maziest cave in the world. "Passage network density" is a statistic developed by Ukrainian speleologist Alexander Klimchouk to describe the famous gypsum maze caves in that country (far away from Russian invaders). Sarah averages about 1.5 miles of surveyed passages underneath each acre of surface (600 km/km^2). The version of the working map illustrated with this article (see page 10) shows several sets of joint-controlled crawlways spaced every 6 to 8 feet, forming a network of dense mazes. No point in the 7+ miles of surveyed cave is more than about 600 feet from the entrance. Team Sarah uses a trail system and

maps of permanently-marked survey stations to avoid getting lost.


The cave is unusual in other ways too. Anthodites, helictites, and gypsum needles are common. A vein of iron ore forms the ceiling of the passages, most of which are crawlways and some of which qualify as "Pennsylvania borehole." Portions of the cave were mined for that iron ore during the Civil War, which enlarged some cave passages into stoopways.

Sarah Furnace Cave is located about an hour northeast of Pittsburgh. It is the biggest of Pennsylvania's well-known Vanport limestone maze caves. Some may quibble over whether this location is in the northeastern US, but we refer any naysayers to the Northeastern Cave Conservancy's logo, which includes a map including all of Pennsylvania. The Vanport limestone is only 8 to 10 feet thick and nearly flatlying; the cave's vertical extent is all of 20 feet. McFails veterans can leave their vertical gear behind

Team Sarah has enrolled over 100 members, many of which had never surveyed before visiting Sarah. If you're interested in surveying virgin cave in the longest cave in the northeastern US (and in the maziest cave in the world), contact me at caving.ashbrook@comcast.net.
