## Hosterman's Pit Status Report

[Ed. Con-Stone, Inc. has filed an application for a permit to surface mine limestone. The mine would destroy most of Hosterman's Pit.]

Things are looking a little brighter. On November 15, 1993, the Environmental Quality Board approved our petition to designate the property which overlies Hosterman's Pit and Stover Caves as Unsuitable for Mining. On December 25, 1993 the proposal was published in the Pennsylvania Bulletin. There is a 30-day public comment period. After the comment period, the Independent Regulatory Review Commission (IRRC) will vote on the petition. Then it must be finally approved by the Environmental Quality Board.

The vote by the IRRC is a real hurdle to overcome. That's because the commission is more political than the other groups which have had to approve it up to this time.

The Nittany Grotto does not plan to initiate another letter writing campaign. They will, however, be asking specific individuals to respond during the public comments period and to write to the IRRC members.

I have begun talks with a real estate lawyer to understand the legal ramifications of offering Con-Stone, Inc. a specific sum of money for the property with a right-of-way and cavern rights. Where this will all lead is anyone's guess.

Meanwhile, Con-Stone, Inc. continues to provide additional information to DER to address the shortcomings in their original application for a mining permit. The Unsuitable for Mining (UFM) process does not constitute a blocking action on the permit process, therefore it is conceivable that Con-Stone, Inc. could get a mining permit before the area could be designated UFM. That's how it works!

The good news is that it will take years to reach Hosterman's Pit if Con-Stone follows their original mining plan.

The Nittany Grotto thanks all of you who have written or called the EQB to support the notion that Hosterman's Pit deserves to be saved. And also thanks the individuals and organizations who have bought Hosterman's T-Shirts and donated time and funds to the effort.

The grotto is still accepting donations. All funds remaining after the Hosterman's project will be used for other cave conservation efforts.

### Hosterman's Pit T-Shirts

The Nittany Grotto has a few (size large only) T-shirts for sale. The shirts are grey with the front design in blue, yellow and black. The front of the shirt displays a map of Hosterman's Pit along with a replica of the old Nittany Grotto keystone patch. The back of the shirt has the words; Hosterman's Pit "I did my part to save the cave..."

The shirts cost \$15 and will be available at the MAR business meeting.

The net proceeds from the sale of the shirt will be placed in the Grotto's Cave Conservation Fund. These funds are used to defray expenses for the project to save Hosterman's Pit.


Sites and Hosts of Recent MAR Field Meets

## MAR Business Meeting Minutes

#### Saturday Feb. 27, 1993

[Editors note: These minutes were prepared from hand written notes supplied by the secretary, Bill Wolford. They are not meant to be the official record of the meeting. They are presented here for whatever use you can make of them.]

The meeting was held at the Jay Herbein residence 625 Carbon Ave. Harrisburg, PA

It was called to order by Chair, Jim Kennedy at [probably 1:30 p.m.]

All four officers were present

Chair - Jim Kennedy V-Chair - Keith D. Wheeland Secy - Bill Wolford Treas - Bette White

Previous minutes were accepted as corrected.

Treasurers report - Feb. '92 \$2,502.70 - Feb. '93 \$3,369.22

Editor of MAR Breakdown will tape the newsletter shut before mailing.

MAR Bulletins - Will White reported that Bedford Co. is done,

Jim Kennedy reported that 2/3 of the fieldwork is finished for approximately 60 caves in Fayette County.

Pa Cave Database - Keith Wheeland reported that there are 1,205 caves. He periodically gets requests from engineering firms who are doing projects which need cave location data.

Cave Conservation Signs - Bert Ashbrook reported that there are 31 signs distributed. That means there are 19 signs still available. Someone reported a problem with letters rubbing off. Bert will check. It was decided to print more signs when the supply drops sufficiently. The price will remain \$10.

Cave Registers - Judi Stack reported there are 42 registers in the MAR.

NCRC - Jeff Uhl has relinquished his duties so Trish Geiger reported on upcoming dates. Chuck Hemple reported that Nittany Grotto had requested funds for a Furno Washington litter. The retail cost is about \$400 and street price about \$325. Hemple made a motion, seconded by Judi Stack that the MAR fund \$150 of the purchase with the stipulation that the litter would remain the property of MAR, would be stored in the Nittany Grotto cache, and would be available for cave rescues within the region. Passed.

Pennsylvania Cave Conservancy - Larry Clauser reported that there may be some movement afoot to allow access to Dreibelbis Cave again. Larry is in favor of the voluntary moratorium on winter caving in Sharer Cave because of the extensive bat population.

Will White reported that Aitkin Cave is now owned by The Nature Conservancy and that it is not easy to get trips into the cave, although it is possible.

Old Business - Bill Wolford reported that the Loyalhanna Grotto lost about \$200 hosting the MAR Fall meet in '92.

Ken Jones reported on the upcoming MAR Spring '93 meet to be hosted by the Franklin County Grotto.

Keith Wheeland reported on the status of the project to save Hosterman's Pit. No action was taken on discussion for MAR to make a donation to the project. Sales of Hosterman's Pit T-Shirts were brisk.

Chuck Hemple reported on the status of the project to protect the caves in the hillside area of Chestnut Ridge.

New Business

MAR Fall Meet '93 - No volunteers to host the meet.

MAR Spring Meet '94 - No volunteers to host the meet.

NSS questionnaire asking for the opinion of MAR on changing the rule requiring 100% of members be NSS members. Will White mad a motion, seconded by Judi Stack to have the MAR secretary write a letter to NSS informing them that the issue was not applicable to the MAR. Passed.

Bette White will send the MAR's Employer's Identification number (E.I.#) to the NSS as now required for an Internal Organization (I.O.). Keith Wheeland noted that the copy of the 1992 MAR I.O. report was available for review.

Durham Cave - Bert Ashbrook reported on the status of offering this cave to the NSS. Greater Allentown Grotto would act as caretaker.

Laurel Cavern Cleanup - John Chenger reported on this upcoming event.

Bulk Rate for mailing was discussed. Referred to committee to study.

McAlisterville Gate - Keith Wheeland reported that the gate was missing.

P2G2 flier was distributed by Mike Mostardi.

BCCS Mapping Seminar - Jeff Uhl reported that the seminar was very successful and thanked all who helped make it a success.

Dale Ibberson reported that he had copies of a report written by Bernie Smeltzer for the Chatham Central School.

Bernie Smeltzer Map Display - Hope Uhl reported on the display that was presented at the NSS '92 Convention. It is being maintained by Greater Allentown Grotto and is available for grottos to borrow.

Hope reported on her efforts to establish a Bernie Smeltzer Award for cave cartography.

NSS Convention '95 - Carol Tiederman reported that the convention will be at VPI and will be hosted by grottos in the VAR. The dates are July 16-22, 1995.

PA Cave Fauna - Rich Rosevear is compiling a bibliography. Send information to him.
