2024 Spring MAR Field Meet McClure, PA

The 2024 Spring Mid-Appalachian Regional (MAR) Field Event, hosted by Bald Eagle Grotto, took place from May 17th to 19th at the Bean Soup Festival and Fairgrounds in McClure, Pennsylvania. This was the first time the event was held at this location, and it drew 140 cavers for a weekend of exploration and fun. The fairgrounds offered a fantastic setup for camping, and congregation, making it the perfect base for the weekend's activities.

Bright yellow signs, along with the Bald Eagle mascot, Jack the Eagle, dotted along route 522 helped to guide cavers to the event.

Cavers started arriving on Friday around 5 PM, and Jesse and Mary Young were ready to assist with registration until late in the evening. They ensured that everyone received their meal and door prize tickets, setting the stage for a well-organized and enjoyable weekend.

Saturday morning began with coffee and donuts to help wake up the crowd and get everyone energized for the day's adventures.

The event featured both guided and non-guided cave trips. Participants explored McClure Cave and the historic Alexander

Caverns, the crown jewel of Bald Eagle Grotto. Other cave trips included Maitland Cave, Kooken Cave, McAlisterville Cave, SeaWra Cave, Milroy Cave, and Womer Cave, all within 30-45 minutes of the campgrounds.

Vendors added to the event's vibrant atmosphere, with Outstanding Stitches showcasing their custom caving and outdoor gear, as well as offering general gear repairs. The Mid-Atlantic Karst Conservancy (MAKC) also participated. Cavers were encouraged to shop local to support the small community of McClure and its surrounding area.

Evenings were spent around the campfire, where cavers gathered to share stories, laughter, and a frosty beverage (or two). The warm fire and lively conversations fostered a strong sense of community and camaraderie.

The Saturday evening meal, provided by Airy Dale Farm Market, was served in a spacious covered pavilion and featured pit roasted BBQ chicken, baked potato, baked beans, garden salad, and fresh-made strawberry shortcake for dessert. A Remembrance through Caving Equipment The Gordy Ley Collection and Auction

Gordon "Gordy" Ley was a South-Central Pennsylvania caver of some repute. Skilled in many aspects of caving, surveying, vertical and micro-blasting, he had a wide and rich legacy around the PA caving community, as well as farther afield. Gordy left the caving community too soon, but the stories of his explorations and exploits still allow him to live on around the campfires.

In the course of a caving career, one acquires a tremendous amount of equipment and gear. This takes many forms as caving disciplines can be diverse as in surveying, vertical work, rigging, entrance improvement and rescue. Gordy was no stranger to the many aspects in caving, and his equipment collection reflected his wide interests.

Many long time and veteran cavers will have an issue to deal with upon their own passing, especially if their spouse or significant other is not a caver. The Stuff. The Equipment. The ever increasing in size PILE OF GEAR. When Gordy left us, he left behind a vast amount of equipment and gear.

Two veteran Franklin County Grotto (FCG) cavers, Pat Minnick and Bill Geller, stepped up to assist Gordy's wife in assisting with Gordy's estate with the caving gear. So, what to do? First off, it needed an inventory. Pat and Bill were easily able to identify the obvious caving and outdoor gear that Gordy used on caving trips. When the inventory was done, they had an amassed several totes, boxes and containers of gear, as well as a handwritten inventory list that ran several pages. Pat's wife Anne did a spreadsheet of the gear list that made things much easier for the itemization of all the gear and eventual auction accounting.

Gordy's gear pile was very happy in Pat's basement, keeping company with all of Pat's caving and rescue gear as well, and were having a grand old time of it. But it was decided that Gordy's gear needed to be adopted by new owners and travel on to its new forever homes.

But how?

Caving gear is a fickle thing. It all supports life in some way, when being used in the underground. In some ways it's very direct life support like with rope or carabiners, things that were in that pile of Gordy's. In some way's it's passive, like with survey gear or gear boxes. Selling this type of gear is difficult because of that life support issue. Gear needs to ALWAYS be inspected and assessed, especially if it's used, and placed into use accordingly.

The social media craze gave rise to gear swap pages and sales pages, but much of Gordy's gear was vertical. It needed to be inspected in person by the buyer and determined by the buyer if it was right for them. After all, it was their life that was going be at risk.

The sheer volume of stuff made social media sales impractical. No one had time to post the hundreds of items and answer follow up questions. An in-person event was needed. But what? And when?

Finally, it was settled upon the MAR Regional Event. It had the best chance of a wide range of cavers with varying interests being present, as well as being fairly soon.

But how to sell it?

Again, we needed a plan. Pat and Bill had an inventory, but there was A LOT of stuff. And the inventory was batched into entries like "Six locking carabiners" and "Rope, length and origin unknown." A better inventory and inspection for description was needed.

Your humble author had decided to volunteer to assist in helping Gordy's gear find it's new forever homes. One spring morning, Bill and I met at Pat's to begin the adventure.

The process centered more on how to sell the lot rather than conduct a detailed accounting. Another long-time regional caver, Tom Griffin, had proposed the idea of a silent auction, rather than a live auction. Which was brilliance on Tom's part, and rather relieved your humble author, who thought he was going to have to live auction several hundred bits of gear, and who wasn't happy at the thought of having to have ten to fifteen ways to describe individual locking carabiners, along with the hundreds of other items.

Now the real fun began, what was each thing worth? And each thing was used so that depreciated the value. And there was no Kelly Blue Book lookup for a 11mm rope of indeterminate length or age. A few key things, we set an opening bid at, but Tom's wife, Red as well as York Grotto member Jade Vogel, assisted in the valuation and "bundling" of items that seemed to go together. Seven Valleys Grotto's Ziggy Seager and FCG's Dave Scamardella also assisted in valuation of items and helping out with the auction. All in all, with a few exceptions, we let the caver market determine the value of the items by allowing opening bids to be set and then competing bids to be placed until the fair value seemed to be reached, and bidding stalled.

The auction proceeded throughout the day with cavers wandering in and out, checking gear, placing bids and re-placing bids higher on goodies they really wanted. The auction was set to end fifteen minutes after the end of the feature program. The last thirty minutes saw a lot of bidding action, with several items generating some bidding wars between cavers.

Finally, it was pencils/pens down and the next bit of fun began. The payment stampede. With a flurry of cash that made it seem like a cattle trading day at the stockyards, all the items were bundled up and paid for with Red, Jade, Tom, and myself all changing cash out with each other to make change for purchasers. A very appreciative shout out here to Rick Smith, Chair of Bald Eagle Grotto and the MAR Event Chair for allowing several purchasers to use the Bald Eagle Venmo account to pay for their items.

And so, the auction of the Gordy Ley Collection of caving gear was over. In the whole duration of the auction, one thing stood out to me after it was over. It wasn't over. Gordy's legacy through the cave gear will live on. It was great to hear cavers looking over a bit of gear reminisce about a Gordy trip, event or story that the item brought to their memory. And that, to me, was the caver value of the auction.
